NOTICE IS GIVEN that the Suisun Resource Conservation District (SRCDD) Board of Directors will hold a special meeting to conduct a public hearing on April 14, 2021 at 10:00 AM via web conference (ZOOM: <https://us02web.zoom.us/j/84674081525> or 1-669-900-6833; code: 84674081525#) to consider a SRCDD Staff recommendation regarding an Amendment to the SRCDD's component of the **Suisun Marsh Local Protection Program (LPP)**. The Suisun Marsh Preservation Act of 1977 requires the SRCDD to administer a Local Protection Program including a water management program for each of the privately managed wetlands in the Suisun Marsh Primary Management Area. SRCDD's LPP was originally adopted in 1980.

SRCDD Staff will recommend that the SRCDD Board authorize revisions to each of the existing private managed wetland water management programs and update them as Individual Ownership Adaptive Habitat Management Plans (Plans). The Plans identify multiple water management program options and each private owner's water management infrastructure in the Suisun Marsh primary management area. These plans have not been updated since first adopted in the 1980s. The SRCDD Staff will seek authorization from the SRCDD Board and San Francisco Bay Conservation and Development Commission (BCDC) to modernize the water management programs and Plans. The hearing will be conducted in accordance with 14 CCR § 11210(d).
