**RESTRICTIONS SUMMARY:** *(Taken from the Army Corps of Engineers Regional General Permit SPN- 2012-00258 for the Suisun Resource Conservation District, page 8, Condition #13).* – **“Landowners diverting water from designated sloughs (see enclosed map) shall obey unscreened water diversion restrictions described in the USFWS BO dated June 10, 2013 pursuant to intake capacity restrictions between April 1 and May 31.**

**If during this time, two out of the three CDFW 20-millimeter trawl survey sites (606, 609, and 610) predict Delta Smelt densities greater than 20 Delta Smelt individuals per 10,000 cubic meters over a two week sampling period, all diversions from these sloughs shall use only 20% of the water control structures intake capacity”.**

SRCD will review the CDFG 20-millimeter Delta Smelt trawl and determine what diversion restrictions currently effect unscreened diversions. **Currently, the diversion restriction is not to exceed 20% open.** If Delta Smelt monitoring conditions change, SRCD will notify you by mail of an increase to 35%. The diversion restrictions are based upon the size of the gates for the following opening measurements.

<u>Diameter of Pipe</u>	<u>20% Open</u>	<u>35% Open</u>
12 inches	3 inches	5 inches
18 inches	4 inches	7 inches
24 inches	5 inches	8.5 inches
30 inches	6 inches	10.5 inches
36 inches	7 inches	13 inches
48 inches	10 inches	17 inches

SRCD will be checking all intake gates in Delta Smelt restriction areas by boat during the monitoring period. Intake gate closed measurements collected during past monitoring periods will be used to ensure compliance. If there are any questions regarding these restrictions contact the SRCD office at (707) 425-9302 and talk with Steven Chappell.

Clubs that have fish screen facilities or intake gates on sloughs other than those listed as areas of critical Delta Smelt habitat may divert water during this time without restriction.

**NOTE!** If a gate is inspected and found to be open in excess of stated diversion restrictions, the landowner will be immediately notified by telephone and requested to reduce the diversion to the appropriate level. If telephone contact is unsuccessful, then a notification letter will be sent. The U.S. Fish & Wildlife Service, the National Marine Fisheries Service, and the Army Corps of Engineers will also be notified if an intake gate is open and noncompliant. This monitoring is a requirement of the SRCD Corps of Engineers Permit and noncompliance could jeopardize the permit for the entire Suisun Marsh.
